MINUTES OF THE CITIZENS' BOND OVERSIGHT COMMITTEE OF OCTOBER 16, 2008

Associate Vice Chancellor Parsons asked for the committee members to agree that District Student Trustee Ruth Jones could vote for Kyl Myers, Student Member, at the meeting. (No objection from committee members)

New committee member Tom Kenney was introduced.

Associate Vice Chancellor Parsons called for nominations for Committee Chair. Mr. Unitt nominated Mr. Serbantes as president; Mr. Kenney seconded nomination. Committee unanimously approved the election of Mr. Serbantes as Chair for 2008/09.

ELECTION OF OFFICERS

Chairman Serbantes called for nominations for Vice Chair. Mr. Kenney nominated Mr. Unitt; nomination was seconded by Ms. Jones. Committee unanimously approved the election of Mr. Unitt as Vice Chair for 2008/09.

APPROVAL OF MINUTES

Ms. Renee Graves from Vicenti Lloyd & Stutzman presented the annual independent audit of Measure C expenditures. The Committe accepted the audit report as an information item.

MEASURE C AUDIT REPORT

Mr. Rick Hernandez distributed a spreadsheet detailing Measure C project commitments to date and discussed planning and construction progress. Mr. Kenney asked about the likelihood of bids coming in at a lower cost given the economy and Mr. Unit asked whether project labor agreements are used at the District. Mr. Hernandez reported that there was a trend toward lower bids, Dr. Buysse discussed the Board's passage of a resolution emphasizing the District's commitment to hiring local contractors, and the range of outreach efforts that have been made to local labor unions. The committee also discussed the components of the Moreno Valley Campus Phase III project, and Ms. Jones discussed the fly-through video presentation that showcases the planned Student Success Center on the Norco Campus.

MEASURE C PROJECTS UPDATE

Mr. Aaron Brown distributed and discussed the Measure C financial summary report, current through June 30, 2008. Mr. Brown also discussed current bond issuances, past refinance benefits, and remaining balance available for future bond issuances.

MEASURE C FINANCIAL UPDATE

Dr. Buysse discussed the situation at the state and the fact that a statewide education bond would not be on the November ballot. The effect of this would be to push RCCD project back at least a year; these projects include Riverside School for the Arts, and Moreno Valley Phase III. He also discussed the possibility that the projects would have to qualify again for the the state construction queue.

STATE EDUCATION BOND STATUS

Committee determined the location for CBOC meetings Through October 2009: January 15 at the Norco Campus; April 16 at the Moreno Valley Campus; July16 at Riverside City College; October 15 at Norco Campus (or possibly at one of RCCD's other education centers such as the Ben Clark Training Center).
