## **Audit Report**

Renee Graves principal with CliftonLarsonAllen LLP provided the 2017 Bond Audit report. The audit materials were shared and Graves provided the report with the following, "A clean unmodified opinion and the financial statements on the bond fund itself are fairly stated and follow appropriate accounting principles." The audit conclusion states, "The results of our tests indicated that, in all significant respects, the District has properly accounted for the expenditures of the funds held in the General Obligation Bond Funded Capital Outlay Projects – Measure C Bond Program and that such expenditures were made on authorized bond projects."

### **Measure C Financial Update**

Project Commitments Summary Series A, Series B, Series A Refunding, Series 2007 C, Series 2010 D, Series 2015 E as of September 30, 2017

Vice Chancellor of Business and Financial Services Aaron Brown provided the Measure C Project Commitments Summary. Committee members received the financial report with the summary of activities from the past report. The summary reflects a decrease in the cash balance since July 2017 by \$351,000; the interest income investment line has been adjusted by about \$39,000 as a result of actual interest earnings for the 2016-17 year and a projection of earnings for 2017-18. In-progress projects has increased by \$484,000 as a result of feasibility and planning line item. From an expenditure standpoint the major expenditures that increased to account that change in cash of primarily \$300,000 are construction-related activities associated with the Culinary Arts Academy and District Office, Coil School for the Arts project, approximately \$56,000 related to construction closeout items on the Charles A. Kane Student Services and Administration building at RCC and the Network Operations Center at MVC had about \$170,000 in expenditures.

Q: Cuevas – When the Board approves a project budget in this column called "current approved," is it when that particular project came to being, was presented to the Board and they approved it?

A: Brown –Because this includes staffing costs and a consultant who was acting in a staffing capacity, those are monthly costs that are being charged to Measure C, so it is part of our District adopted budget.

### **Project Summary**

- Q: Cuevas Does the booster repeater benefit those walking outside, say on Magnolia?
- A: Doering No, the antenna has an 80 foot radius so it only benefits those inside the building.
- Q: Cuevas Because this benefits the students I can see how this is a capital improvement, but otherwise isn't this a cell phone company issue.

A: Carlson – The issue is that the booster pulls the service into the building to assist the queuing system which wasn't functioning due to a deficiency. Therefore, we had to create a new project to complete the work since it was not identified during construction. The queuing system was designed for that building and there was a need for it to work properly, thereby qualifying it as a Measure C project.
