Add Section 5.51

<u>Re-appointment</u>. Members of the Committee may be re-appointed by the Committee upon request, subject to the Section 5.4.

Amend Section 5.6

Removal; Vacancy. The Committee may remove any Committee member for cause. A Committee member shall be sufficiently-noticed of the allegations and have an opportunity respond at the next Committee meeting to any such proposed removal. Upon a member's removal, his or her seat shall be declared vacant. The Board, in accordance with the established appointment process shall fill any vacancies on the Committee. The District shall seek to fill vacancies within 90 days.

<u>Amend Section 10</u>. Any amendment to these Bylaws shall be approved by the majority vote of the <u>Committee</u>.

RECOMMEND:

- 1) To adopt our current bylaws as recommendations, but adding Section 5.51, amending Section 5.6 and amending Section 10 as proposed by the Chair.
- 2) Form an adhoc committee led by the Chair to vet the current bylaws and propose any other changes at our next meeting for formal adoption of our full bylaws by the Committee.
- 3) Have the Chair write a letter to the Board explaining changes to the bylaws and requesting the that the Committee have a more formal role in the appointment process.

Mr. Hunter--I have changed my mind. I will be attending the meeting, and by copy of this note, urging all Committee Members to attend.

Believe me, I have no interest in having a discussion. I am merely asking for clarification. I think you were in the meeting last week, the same one I attended. During that meeting, despite your protestations that you only wanted a discussion on the proposed bylaw changes, at the end of the meeting you decided to thwart yourself, and call for a vote on the proposed changes. As you recall, that vote failed.

After being stunned by your e-mail, and blind-sided by your call for a Special Meeting, I had temporarily forgotten that most salient action taken by the Committee last week.
