



Pre-Collegiate TRiO Programs






Through our pre-collegiate TRIO Programs (Educational Talent Search, Upward Bound and Upward Bound Math and Science), we serve close to 650 middle school and high school students in MVUSD each year, of which 75% are low income, and will be first generation college students; promoting a college going culture for students in our community.






Articulation

- First articulation one-stop event held (Fall 2015)
- Included training on CATEMA
- Resulted in 18 completed agreements
- Currently 25 agreements in place
- Credit awarded equals \$214,636 savings to students



Riverside County Education Collaborative

- Increase the percentage of students applying to three or more colleges to 60%
- Increase the percentage of FAFSA/Dream Act completions from 52.3% to 93%
- Increase the percentage of students enrolling in post-secondary education from 52% to 65%
- Increase the percentage of students who are college ready using several indications such as the early assessment program (EAP), UC/CSU A-G completion rates, and community college multiple measures/course placement




The following outcomes are based on AB705:

- Increase the numbers of students who enter and complete transfer level English and mathematics/quantitative reasoning in one year
- Minimize the disproportionate impact on students created through inaccurate placement processes.
- Elimination of Accuplacer
- Use MMAP/AB705 matrices which include high school performance indicators

English Placement (2017-2018)



Math Placement (2017-2018)








The MVC Promise Initiative covers student enrollment, other college fees, and vouchers for textbooks during the first year of college



First Year Experience Program MVUSD Students








First Year Experience Program 2018-19



- Summer Bridge program is designed to help close equity gaps
 - 582 students completed a Guidance course to help increase awareness of college resources and personal factors that contribute to success
 - 28 basic skills students who participated in a English workshop are now in English 1A
 - 50 college level students completed English 1A during summer are now in English 1B
- Improved summer bridge math course activities
 - 12 students completed Math 35
 - 12 students completed Math 52
 - 9 students completed Math 65
 - 33 students have moved up one level during the 6-week summer session



Degree & Certificate Completion 2014-2015 through 2016-2017 (MVC All vs MVUSD)






Transfer Numbers 2014-2015 through 2016-2017 (MVC-All vs MVUSD)
