Chancellor Isaac expressed concern that even with the start of classes in October, we have not been able to significantly change our enrollment status; it remains about 27% below target. Work continues in devising different creative promotional means to improve enrollment status during the winter and spring semesters.

Thanks to our Government Relations office and Congressman Takano for efforts to bring dignitaries to our district, it has enabled us to host the Honorable Denis Richard McDonough, U.S. Secretary of Veterans Affairs to a breakfast meeting provided by our distinguished and remarkable Culinary Academy students at our Rooftop on October 6, 2021. Norco College made an impressive presentation on the work that they have been doing on the organization of the Military Articulation Platform which allows veteran students to earn up to 30 units of credit for their time in the military. This model which is fully implemented at RCCD and is being scaled at regional and state levels in California in collaboration with the state Chancellor's office. VA Secretary McDonough was impressed with the presentation and is interested in seeing this program grow at the national level. In July, we hosted the U.S. Secretary of Labor, and he focused on Early Childhood education and Culinary.

RCCD presented three papers, one from Norco College and two from RCC (Nursing and Role of Student Success Coaches in Guided Pathways ensuring Equity) and Trustees Alcala and Vackar delivered introductory remarks. The presentations were well received and generated many questions and much interest. Five community college trustees were elevated to a national level, including our very own Trustee Alcala. Congratulations and best wishes for success. The conference attracted many impressive keynote speakers and was very instructive. Colleges and their Trustees are struggling to transform campuses into antiracist institutions. How to go about it is very complex and it is a long journey. Yesterday, he, President Steinback, and Trustee Vackar represented the District at the Celebration of Life for Victoria Baca, Mayor Pro Tem of Moreno Valley. Trustee Vackar gave a moving speech and it was a beautiful tribute to her life and commitment to the City.

This morning there was a historic groundbreaking for construction of a housing facility for homeless, which will house 49 people and provide much needed health support services and was organized by TruEvolution, whose mission is to fight for health, equity and racial justice, to advance the quality of life and human dignity of LGBTQ+ peoples. Assemblywoman Cervantes and Assembly Majority Leader Eloise Reyes helped coordinate funding of \$10M and were among the dignitaries present for this impressive ceremony.

Ms. Rasheed advised the Board of Trustees that there are no open cases at this time.

Trustee Vackar thanked RCCD for the opportunity to present at the ACCT conference and share the information with colleagues across the country, especially because it was faculty driven. Commented on the services of Victoria Baca and the history that they shared in working with the community. Reported that the call with the Legislative Advocate and the importance of expressing what's happening with enrollment ad that we really need their support to make sure that our colleges stay whole. She thanked everyone for all the great work they are doing.

Trustee Alcala commented that it was great to be part of the BCTC Groundbreaking. He enjoyed being part of the team on the RCC Nursing program presentation. Conversations with trustees around the country revealed that other institutions are in awe of what the RCC program has accomplished. BUSINESS FROM BOARD MEMBERS

Update from Members of the Board of Trustees on Business of the Board

Looking forward to attending RCC theatrical performances and continuing to support Tiger sports. Asked that everyone please support the RCCD Police Department Pink Patch project. Asked that President Steinback convey thanks on behalf of himself and the staff at March Mountain to the MVC folks that came out and worked with the students. Expressed his appreciation for the work, passion and support that Victoria Baca gave to Moreno Valley. She will be missed.

Trustee Figueroa reported that she has received quite a few questions about the manner in which the Board of Trustees meetings are being conducted in terms of social distancing, when the campuses are not, especially in the classrooms. We will need to look at all of the rules and regulations that we are operating under. Yesterday, Riverside County was dropped to a "Substantial" rate, which is under 10%. We will take a look at it so that people do not feel we are operating at a position that is any more important or higher than anybody else. She referenced the report of a woman that was raped on a train on the East Coast, in full view of numerous witnesses. We are living in a society that turns a blind eye to an actual sexual assault that occurs right in front of them and no one does anything other than to videotape it. We've seen the impact that the rise in sexual assault has had on our campuses. She is requesting that the Chancellor look into having our police department offer type of rape and/or sexual assault awareness/education sessions, either virtual or in-person. It is the most underreported crime. We need to ensure ALL of our students are safe.

Issues of mental health was brought up at ACCT. She relayed the incident at Chapel Hill, NC, where two students committed suicide and the institution closed down for two days at the request of the students. Mental health issues of our students are exasperated due to the pandemic and a lack of access to services. We need to take a look at the mental health of our athletes. Do we have enough counselors to provide services to our students? We need to be aware of student issues so that we offer the most amount of resources and assistance to our students before they ever get to the point of committing suicide. The issue came up about the money that all districts are receiving from the CARES Act and how the money is being utilized. Is it being used to assist the students, staff and population or where is that money being utilized?

We need to be able to know that we are accountable. Let's find out where that money is going so we know that there isn't something that we should be addressing that is not being addressed. At ACCT, received numerous comments of positive feedback from other trustees, and that's never happened before. This is one of the few opportunities that the faculty and staff have to work directly with trustees and why it's important to have a trustee included in these types of presentations. She congratulated Trustee Alcala on his appointment at the national level and suggested that he take a look at the five committees we have under ACCT and also put his name in for one of those committees. She congratulation VC Goldware and her staff for the very successful visit with the U.S. Secretary of Veterans Affairs. President Figueroa shared that she has not been able

to attend events that she usually attended in the past due to health issues.

The Board adjourned to closed session in honor of Victoria Baca at 8:10 p.m. and reconvened at 8:40 p.m. after considering the following closed session items:
