COMMENTS FROM THE PUBLIC

Enrollment continues to be a challenge and is still 28% below target, one of the highest in the state. Efforts are being made to help find a way out of this hole, including use of HEERF funds, which will be reported later in this meeting. Riverside City College and Norco College have been recognized as Champions of Transfer, in spite of the challenges we are facing. On October 30, a ceremony celebrating the life of Dr. Salvatore Rotella, the first Chancellor of RCCD, was conducted in New York City. I attended on behalf of the district and was joined by fellow Riverside representatives Mrs. Dorothy Hartley and Congressman Takano. Today Trustee Hedrick and I met with the Jurupa Valley City Council, Jurupa Unified School

District, the Labor Council and Congressman Mark Takano's office to discuss the Inland Empire Technical Trade Center project, including identifying land and rezoning. They expressed a deep commitment to the project. Inconsistency in social distancing between the colleges and the district office was discussed at the last Board of Trustees meetings. Based on CDPH and CalOSHA removing social distancing requirements in June, 2021, Director of Risk Management Beiwei Tu recommends discontinuing the six-foot social distancing, one-way traveling and room capacity at the District Office and Board of Trustee meetings.
