Reports from Colleges

1. Moreno Valley
 - a. The Ben Clark Training Center is officially Moreno Valley’s first college center.
2. Norco
 - a. The Norco Curriculum Committee is raising the question about allowing for local DE approval for district wide courses, along with the timeline for standard DE proposals for 22WIN/SPR.
3. Riverside

- a. Ellen Brown-Drinkwater gave a great presentation on credit for prior learning, which led to robust conversation.
- b. Kelly Douglass attended the Senate meeting yesterday, and Mark Sellick mentioned that Dr. Isaac has made it very clear that there is no data to support that we will be in an emergency closure situation in the fall. Despite the Curriculum Committee's statement regarding DX, the instructions to the scheduling is that a standard DE is required for scheduling.
- c. Last fall there was a discussion regarding developing an equity guide, which was sent out at the beginning of the semester. On the curriculum listserv this week, two colleges shared some potential resources based on work done at their own colleges.

Discussion Items

1. Catalog Addendum Update – Bryan Nicol
 - a. A question was raised regarding the ability to post the CSUGE and IGETC sheets to an addendum once they have been updated. Because the new ERP will require the programs to be manually built, we will be able to accommodate the articulation updates in the addendum.
2. AOE Discussion – Ann Pfeifle
 - a. When the coordinators, chairs, and AOs met to review the forms, a question regarding the guidelines for adding courses to the AOE's was discussed. Are the guidelines currently in the handbook appropriate?
 - b. Brian Johnson – Regarding approval process, in the past, any course additions to the AOE's were collected, and then a first and second read were performed by the committees with all the changes. Recently, however, we have had fewer additions to AOE's come through the curriculum process.
 - i. Kelly Douglass – Recalled that the courses were each reviewed as they came through, but the final changes were vote on as a whole in the spring.
 - c. Ann Pfeifle – As the handbook has just been approved, perhaps this topic can be held for now, or discussed with Academic Standards.
3. Curriculum Institute
 - a. The colleges are beginning to compile a list of individuals to send to the curriculum institute including faculty, staff, and administrators.
4. Brown Act and Governor's Executive Order
 - a. This topic will be agenda'd for the following DCC. The question of whether the

- Tech Review and DCC committees are able to continue to meet digitally, along with the degree to which they are bound by the Brown Act was raised.
- b. Brian Johnson recommended that the committee receive training on how to run a meeting in accordance with the Brown Act.
5. Business Administration 2.0 ADT Language
- a. Riverside and Norco have each added language to the narrative of the Business Administration 2.0 ADT indicating that the faculty's preference is for students to complete MAT-12/12H, but that PSY/SOC-48 is an approved exception due to having the same C-ID approval. Generally, MAT-12/12H are more widely accepted for CSU Business programs, and there is the possibility that a CSU may deem an ADT offered by RCCD as not similar to a CSU degree. This would cause the student to need to take additional courses once they transfer to a CSU.
 - b. Jeanne Howard – If the CSU does not want students to take a specific course, this could lead to the CSU deeming an RCCD ADT as “not similar.” Because of this, it would be better to not list PSY/SOC-48.
 - c. Ellen Brown-Drinkwater – It also may not be a single course that causes the CSU to deem an ADT not similar. The CSU must guarantee that a student with the ADT can complete the degree in 60 units. If they are unable to guarantee this, they will not accept it as similar.
 - d. Jeanne Howard – When new deans are appointed, they may also change what they are willing to accept for the programs they oversee.
 - e. Jeannie Kim – Indicated the desire to have a separate conversation regarding this issue, and that it could be brought to the provosts of the local feeder colleges.
