- a. Kelly Douglass How are the other colleges recording roll call votes during teleconference meetings? Do these need to be recorded in the public minutes?
 - i. Jeannie Kim Votes do not need to be itemized in the minutes. The score of the votes should just be indicated. Robert's Rules of Order indicate that if someone calls for a roll call vote then the individual tally must be listed, but just for teleconferencing the individual votes do not need to be listed.
- Kelly Douglass Additionally, a RIV only course, POL-14, is very clearly written to have TBA hours, but the TBA box is not checked. The course has not been offered in a very long time and we would like to clerically fix it.

Discussion Items

- 1. AOE Analysis Presentation David Torres, Institutional Research and Strategic Planning
 - a. David Torres, Dean of Institutional Research and Strategic Planning, provided a presentation on the analysis of the data associated with the Area of Emphasis degrees, including time and units to completion, compared to ADTs and non-AOE AA/AS degrees. The data is also available in a dashboard created by David Buitron, access to which can be provided to the curriculum chairs, academic senate presidents, or VPAAs if they do not already have access. The following discussion ensured:
 - b. Ann Pfeifle It appears that the number of AOE awards is increasing, but the share of ADTs is also increasing. AOEs still make up the vast majority of awards, which shows that they are serving students within the district.
 - c. Kelly Douglass Slide 7 shows that the AOEs are the most efficient degrees that students are being awarded. They earn them with the lowest number of units. Slide 10 shows that specifically African American students complete the AOE more efficiently than any other group, so it is particularly successful for that cohort.

- i. David Torres Yes, but also remember the size of the group is small. There are many fewer students, but the ones earning the AOEs are doing so more efficiently.
- d. Kelly Douglass Should the committee be considering the question of whether there should be a limitation on earning multiple degrees? This seems to be the place where the AOEs are awarded with much more frequency. Is there a suggestion to at least think about a policy where students leave with a single degree as opposed to all the degrees they qualify for?
 - i. David Torres Yes, but one concern would be that the AOEs are much more flexible, while the ADTs are much stricter in their requirements. The ADTs lock students into a single four-year system while the AOEs may place students on a pathway to transfer to different colleges.
 - ii. Kelly Douglass If students committed to a single degree, that may be a side question.
- e. Jeannie Kim Additionally, the Chancellor stated that there is the desire to not have any AOEs in the 22-23 catalog. In looking at the data, the workgroup is attempting to develop a plan to phase out the AOEs that are not serving students, to phase in the degrees paths that will serve our students, and to address the issues that will come up from removing the AOEs.
- f. Kelly Douglass We have a Board Policy of Program Discontinuance and the deadline for curriculum to meet the 22-23 catalog is today's DCC. We cannot do a program discontinuance in that timeframe.
- g. Ann Pfeifle Even if we followed through with the Program Discontinuance, we would have to follow our policies and procedures and provide for students over the next several years, so that students can be taught out of the programs. We would need to contact students, and if we do not do that we would be out of compliance with federal regulation and federal financial aid.
- h. Kelly Douglass Even if everyone agreed, the deadline provided to remove the AOEs from the next catalog is not practically or legally possible.
- i. Mark Sellick This also reveals a fundamental ignorance of Academic Senate purview. The Chancellor does not get to tell the Academic Senate to get rid of programs. He does not have that authority. He may want to discuss that with Senate, but he does not get to decide that. This is a Senate issue. He may have his opinion, he is not an Academic Senate President.
- j. Jennifer Floerke What is the composition of the workgroup?
- k. Jeannie Kim The workgroup is comprised primarily of the Articulation Officers and the Institutional Research team, with the goal of preparing information and data and performing an analysis. The AOs had raised several concerns regarding the discontinuance of the AOEs and created a written document of all the considerations involved. The goal was to collect relevant data, and then provide an analysis to the District Curriculum Committee, and then provide it to the Academic Standards committee, followed by any other relevant committees and the Senate.
- 1. Jennifer Floerke Is this following the Board Policy or is this a parallel process?



- m. Jeannie Kim This is not a parallel process. We have a Board Policy for Program Discontinuance and catalog rights must be adhered to. We must also have a full understanding of what it means to develop new ADTs.
- n. Mark Sellick The problem is that we have a process and that process is faculty driven. This discussion appears to be making changes to academic programs in a way that the faculty do not support. The idea that we would pull them from the catalog is insanity. It is insulting to faculty that we are discussing it in this way. Faculty create curriculum. This is 10+1. The fact that we are having this discussion reveals the problems of how this district operates.
- o. Kelly Douglass Board Policy 2021 is the Program Viability and Discontinuance policy. This policy specifically indicates the reasons why a program would be considered for discontinuance along with the procedure for doing so.
- p. Ann Pfeifle Moreno Valley's PA program was forced to go through discontinuance due to something that was outside of our control, and we followed the procedure and provided the students time to complete the program. If faculty are expected to adhere to this process, then that process must also be respected by the administration.
- q. Mark Sellick It also must be a priority that is given by the Academic Senate if it is to be a priority at all. This does not rise to the point where Curriculum and Standards should be considering this. This is not a high priority item and will not be an item brought to the Senate.
- 2. ETS Crosslisting Brian Johnson
 - a. Kelly Douglass Attended the discussion with the ETS faculty and as a part of that discussion there was clarification on what it means for a course to be crosslisted. At RCCD to teach a crosslisted course faculty must have expertise in one area or the other. An ENG/ETS crosslisted course can be taught by ENG or ETS faculty. There were additional questions about if there are other options, but there are not given the way the courses are currently written. If the ETS faculty are concerned about the integrity of the ETS component of the courses, then the approach may be different on a case-by-case basis. Some courses may need to be un-crosslisted, in which case, the pre-existing non-ETS version could keep the course and ETS could write their own. If a new course was developed by both disciplines, then that may be more complicated and may require remediation. There may also be the possibility of creating an 'and' crosslisted option which would require both disciplines to agree that the course should be taught by faculty with FSAs in both disciplines. Those should be rare and very, very clearly necessary and cannot be a decision based on personnel, but rather the content of the course.
 - b. Brian Johnson That would be very unlikely for courses that already exist. A few faculty members, specifically from POL, are very concerned particularly around the courses already approved for Area F. The faculty member is being told by the POL discipline that she cannot and should not schedule these courses. Additionally, there is also a mention in the resolution that all crosslistings should be an 'and', requiring both FSAs.



- i. Kelly Douglass This appears to be a misunderstanding across multiple conversations.
- c. Kelly Douglass In a lot of these situations, if ETS faculty feel strongly about this, which may certainly be appropriate in some instances, the best action may be to delete the ETS version and major mod the original course back to what it was. Then, the faculty could create new courses that cover similar content from a much stronger ETS perspective. Once faculty know what they want to do, we need a meeting with AOs for a timeline and a phased set of options.
- d. Jeannie Kim We also have the new BOG regulation that all of our local degrees must also meet an ETS requirement. This was approved in August.
- e. Brian Johnson Should POL faculty be concerned that there will be something bypassing the curriculum committee, which then goes to Senate, which the Senate then votes to approve?
- f. Ann Pfeifle We are the Senate arm related to curriculum. As a part of the Senate, we can continue to monitor Senate agendas to see if any items come for a vote.
- g. Brian Johnson It's possible that some Senates may say something different.
- h. Jeannie Kim But would that decision meet Title 5, minimum quals, and the FSA processes that we already have? There should be disciplinary rights as a part of this discussion.
- i. Jeanne Howard POL faculty wanted to bring forward several courses that were in the works prior to the ETS. They were already done five weeks prior to when the SLOs for ETS from the CSUs were provided. At that time, the POL courses were then revised with the SLOs because they appeared appropriate.
- j. Jeannie Kim If there is a resolution, curriculum is the group that should make that decision and whatever the process is should be a-personal.
- k. Brian Johnson Can Senate override this on their own?
 - i. Ann Pfeifle The Senates have given curriculum the responsibility to make that decision. Our senate has never voted on curriculum. The curriculum committee has always had the ability to vote on curriculum and send it immediately to the Board.
