1. Curriculum Proposals

Discussion Items and Public Comment

- 1. HLS to PSF Discipline Change Nick Sinigaglia
 - a. Charles Wilhite is seeking to migrate courses in the HLS discipline to the PSF discipline. What is the most efficient way to do this?
 - i. After discussion, the committee recommended cross listing the existing HLS courses with PSF versions. The PSF version of the course should also be added to any applicable degrees.



- 2. FSA List and Curriqunet Permissions Bryan Medina
 - a. Bryan Medina has received a list of current, full-time faculty and their FSAs from HRER and has been reviewing Board Reports for any faculty who have resigned/retired to deactivate them in Curriqunet.
 - b. There is still a large number of faculty who have origination permissions who are not on the full-time faculty list from HRER and who are also not listed on Board Reports as resigned/retired.
 - i. The committee agreed users can be deactivated if they have not logged in within five years.
 - c. Bryan Medina will begin putting together a list to be reviewed by the committee of remaining faculty, their origination permissions, and identifying which permissions should be removed.
- 3. Open Forum
 - a. Casandra Greene Is the committee comfortable with adding mirrored and honors check boxes to the cross listed tab on course forms in Meta? This information can then be added to impact reports.
 - i. The committee agreed with the request.
 - b. Kelly Douglass Is it everyone's understanding that the 180-day timeline for the Title 5 changes to the Course Outline of Record have not yet begun?
 - i. Bryan Medina contacted the Board Liaison with the State Chancellor's Office. According to the liaison, the changes have not been chaptered yet, and the 180 days timeline has not yet started.
 - c. Kelly Douglass Do we have an update on the ability to use fractional units for lectures and labs when the fractional units add to a total awarded unit? For example, a lecture unit of 1.3 and a lab unit of .7, with a total awarded units being 2?
 - i. Lijuan Zhai We are still waiting on a guidance memo from the state, but we believe you can use fractional units as long as the COR reflects it and the total units are whole.
 - d. Kelly Douglass Chef Orlando received a Curriqunet notification of a "Future proposal publishing."
 - i. Bryan Medina This is a notification that approved proposals are now active.
 - e. Bryan Medina Curriqunet has announced that they are being bought out by another company.
