MEMORANDUM OF UNDERSTANDING BETWEEN Riverside Community College District AND

CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS CHAPTER 535

'Community Service Aide Permanent Work Year Increase'

This memorandum is agreed between the Riverside Community College District (District) and the California School Employees Association and its Chapter 535 (together "CSEA").

CSEA and the District agree as follows:

- 1. Work Year: The work year for the currently filled Community Service Aide I (CSA) positions, as of October 22, 2021 listed below, shall be permanently changed to twelve- (12) months. This change shall be effective on January 1, 2022, contingent upon ratification and Board approval of this MOU.
 - **a. Impacts:** Current unit members in the CSA classification who have prescheduled medical appointments, personal business and/or vacation plans between January 1, 2022 and June 30, 2022, which will be impacted by the change in work year, may receive District-provided paid leave for these appointments/plans. To be eligible for this leave, impacted unit members must provide proof of the prescheduled appointments/plans (i.e. reservation or appointment confirmations). The proof must indicate that appointments/plans were scheduled before October 22, 2021 and must be submitted to the immediate supervisor by December 1, 2021.
 - b. Impacted unit members shall be afforded all rights, obligations and privileges' accordingly per the Collective Bargaining Agreement.
