**CALL TO ORDER**

Member Goldware called the Facilities Naming committee (FNC) meeting called to order at 4:05pm.

**APPROVAL OF MINUTES FROM OCTOBER 9, 2025**

Member Harris motioned to approve the October 9, 2025 minutes and member Galicia seconded (8 ayes).

**BP/AP REVIEW AND COMMENTS**

Member Goldware shared that the District Board policy 4400 BP and AP. The BP has minimal updates and the AP has edits and most of the changes are for clarification. Within the AP, signage was updated and tied back to facilities language. Member Harris inquired about the naming of the library moving and the old building was named after the Aery family. Member Goldware shared an example of a building that has a plaque instead of a building name from a previous name on an older building. Member Kaatz shared when a new building is established there is a location within the building that will give honor to a previously named building.

**FACILITIES NAMING REQUEST - QUAD ROOM 240 IN HONOR OF DR. OLIVER THOMPSON**

Member Kaatz shared this is an honorific naming and member Wortman shared that the naming of this room is tied to the classwork that honors Dr. Thompson. Motion to approve the naming of Quad Room 240 was made by member Kaatz and member Wortman seconded (8 ayes).

**FACILITIES NAMING REQUEST - ERIC PERRY SCOREBOARD**

Member Kaatz shared this was a gift from the Perry family and this covers the cost for the scoreboard (minus additional costs around \$2,000). Eric is doing this to support the new

dean of Kinesiology. Member Wortman inquired about additional costs outside of the equipment purchase and the need for electrical support. Member Kaatz elaborated that the gift will cover the bulk of the purchase and the Tigerbackers support group will be picking up the additional costs aside from the equipment purchase. Motion to approve the Eric Perry Scoreboard was made by member Kaatz and seconded by member Harris (8 ayes).

#### **FACILITIES NAMING REQUEST - SAN MANUEL FOR NURSING LAB 252**

The Foundation submitted a grant for the School of Nursing Labs equipment. Motion to approve the naming of the Nursing Lab 252 was made by member Kaatz and seconded by member Bell (8 ayes).
