

#### **Background Narrative:**

Presented for the Board's review is the 2015 Annual Clery Act Report for Riverside Community College District (RCCD). Under Federal Law, the Clery Act or Campus Crime Statistics Act, requires universities to disclose information about crime on and around campuses. The act requires colleges to publish an annual report disclosing campus security policies and three years of selected crime statistics. This year, each college will have the report available on its website and will highlight information pertaining to its safety efforts. The report will also include information on VAWA (Violence Against Women Act) and resources for identifying and contacting a college security authority. The Annual Clery Act Report for RCCD will continue to be published on the District's website and available to all students, employees, and the public at large. The annual report is also published in brochure form.

# Riverside Community College District District Grants Office Board of Trustees Report October 2015

This fall, the District Grants Office introduced a new method of reporting proposal and award activity to the Board of Trustees by reporting specific activity which corresponds to traditional budget reporting on an annual fiscal year basis, the standard for most institutions of higher education. Annual fiscal year proposal and award reports will provide detailed and precise data by source in the current fiscal year and to include the total aggregate funding of those grants anticipated future budget periods for multi-year awards. This new methodology will allow the Grants Office to track activity trends by comparing multiple indicators and compare submissions and awards over multiple years as we move forward.

In fiscal year 2015, Total awards for the period represented 54 grant projects bringing \$16,065,012. RCCD submitted 79 proposals in FY 2015 requesting \$42,513,418 in total dollars. To date, 56 of those submissions have been awarded representing a district success rate of 70.9%. As a comparison, federal sponsors typically fund only 10-20% of the proposals submissions received. Of the 79 proposals submitted, 4 submissions are still pending notification.


Since July 1, 2015, the district has received 19 newly funded awards totaling \$3,712,986 year-to-date for fiscal year 2016. These numbers and amounts to not include continuing awards for multi-year grants newly funded in previous years.

The majority of awards for FY 2015 were received from the state (\$7.8M/49%) followed by federal sponsors (\$7.6M/48%). Awards from non-profit sponsors (\$458K), including foundations, industry and businesses, and other government entities (\$8K) represented 4% of total awards.

The largest number of state awards were made by the Chancellor's Office at just under \$1 million. The largest single grant was the California Career Pathways Trust grant from the California Department of Education at \$6,350,845 in 2015 and a total of \$12,860,892 over four years.

In federal grants, fourteen grants were awarded by the U.S. Department of Education totaling \$5,506,819 in FY 2015. This was the single largest source of grants for our institution. In total, RCCD was awarded 21 federal grants amounting to \$7,689,732 for FY 2015 totaling \$30,486,176 across multiple years.

The District Grants Report includes grants applied and awarded through the RCCD Foundation. The RCCD Foundation was awarded 20 grants at just under \$500,000.
