RESOLUTION NO. 51-20/21

WHEREAS, the California Community Colleges, the largest system of higher education in the country with more than 2.1 million students at 116 colleges, serves a diverse student population, more than any system of higher education in the state; and

WHEREAS, the Riverside Community College District offers open-access and a path to economic and social mobility for students of which 61 percent are Hispanic; 18 percent are White; 8 percent are African American; 5 percent are Asian; with 82 percent under the age of 29; and

WHEREAS, states, counties and cities across America make declarations that racism, xenophobia and discrimination as well as other intolerances are a public health crisis with calls of change for government entities, the criminal justice system, educational institutions, health care centers, social services and housing; and

WHEREAS, the Riverside Community College District recognizes the importance of faculty and staff as leaders of student success as well as drivers of the commitment to promoting equity policy especially when it addresses human and social services, economic development and public safety; and
