2. Approval of Minutes

- a. An email was sent out about the equity FLEX requirement.
- b. Move to approve providing alcohol at all graduation receptions this spring (Philippsen/Haghighat). Approved unanimously.
- c. Listservs are going to be concentrated.
- d. Faculty investigations are out of control. The questions asked about faculty are inappropriate, invasive, and rude.
- e. We need resolution for the endless cycle of accusations/investigations with Faculty vs. Faculty.

 - 1. The committee has decided to meet at least once a semester versus on an as-needed basis.
 - 2. To keep associate faculty apprised of the process (and option), reemployment preference information and details will be disseminated more frequently by the District Office.
 - 3. It is the associate faculty's responsibility to apply for preference.

5. Norco College

- a. Vice President's Report: Virgil Lee
 - i. No report
- b. Full-Time Representative's Report: Araceli Covarrubias

- i. It has been proposed to have Technology Support Services (TSS) centralized in the District. This proposal has been placed on hold until more information is obtained, and all constituent groups are included in the process.
- ii. The Child Development faculty approached the Faculty Association regarding the joint use of facilities between Phillip M. Stokoe Elementary School and RCCD. The agreement provides guidelines for the use of restrooms at Stokoe by RCCD students, faculty, and staff. Part of the agreement includes disciplinary action taken on behalf of ILC Administrator, Principal at the ILC, and RCCD administrative designee. The Faculty Association objects to the language at the end of section 11 that describes the discipline process for staff (i.e., RCCD faculty members) who fail to comply with these guidelines. RCCD Faculty members can only be held to the RCCD/CTA bargaining agreement.
- iii. For clarification, when faculty retire, they do not lose access to their RCCD email account.
- iv. Araceli received a parking violation and was fined \$45 + \$3.75 processing fee. Districtwide, faculty have been cited and issued parking tickets. Motion to issue a demand to bargain parking tickets being improperly issued across the District. (Haghighat/Nelson). Approved unanimously.
- c. Part-Time Representative's Report: Diana Campuzano
 - i. Since a formal appeals process isn't spelled out clearly in the contract, what is the process when a part-time faculty member has a rebuttal to receiving a needs improvement on an IOI? Can the Dean step in and intervene? No, the Dean cannot overrule the subject matter expert who completed the IOI.

6. Riverside City College

 - i. Communication during the shelter in place was atrocious! Rave Guardian didn't work correctly, and the system continues to fail (Within the past year, there was also an incident at MVC where Rave Guardian didn't work properly.)
