## I-9 Verification

**By August 30, 2023**, employers must complete an in-person physical document inspection for employees whose I-9 documents were inspected remotely. The U.S. Department of Homeland Security (DHS) and U.S. Immigration and Customs Enforcement (ICE) announced that employers will have 30 days to reach compliance with I-9 requirements after the COVID-19 flexibilities sunset on July 31, 2023.

Employees hired on or after March 20, 2020, during the COVID-19 pandemic are subject to the in-person physical inspection of identity and employment eligibility documents mandated by the U.S. Department of Homeland Security (DHS) and U.S. Immigration and Customs Enforcement (ICE). Failure to do so may require Riverside Community College District to terminate employment.

In an effort to support our employees through this process, we are offering I-9 Verification drop-in sessions. You will have an opportunity to provide documentation from the <u>Lists of Acceptable Documents</u> to a Human Resources & Employee Relations (HRER) representative. You do not need to schedule an appointment. We have set up the following dates and times.
