NURSING LABORATORY TECHNICIAN

BASIC FUNCTION: Under the supervision of the area Dean, supports and maintains the instructional learning labs.

REPRESENTATIVE DUTIES:

- 1. Takes inventory, classifies, stocks and organizes all supplies and equipment.
- 2. Maintains files and database of instructional supplies and equipment.
- 3. Submits requisitions and purchase orders for lab supplies and equipment; monitors availability of funds; and retrieves supplies from hospitals or other community agencies as needed.
- 4. Checks and calibrates equipment, such as glucose monitors, vital sign machines, etc.
- 5. Examines medical equipment for operability and performs minor repairs. Prepares equipment in need of repair for shipment.
- 6. Ensures medical supplies are not expired, if applicable.
- 7. Creates faux medications for instructional labs as requested by faculty.
- 8. Pulls supplies for instructional labs as requested by faculty.
- 9. Maintains and ensures supply storage areas and instructional labs are clean and in order.
- 10. Coordinates the removal of bio-hazardous waste.
- 11. Sets up instructional lab areas as requested by faculty.
- 12. Participates in training programs.
- 13. Performs other duties, related to the position, as assigned.

EDUCATION AND EXPERIENCE: Graduation from high school or GED equivalent and at least one year of generally related experience in office practices, inventory methods, and use of medical equipment is required.

LICENSES/CERTIFICATIONS: None.

KNOWLEDGE OF:

- Methods and procedures used in receiving, issuing, and accounting for material, supplies, and equipment;
- Nursing and medical supplies and equipment;
- Basic office practice skills, including word processing, filing, and answering phones.

ABILITY TO:

- Keep records;
- Establish and maintain effective working relationships with others.

CONTACTS: Co-workers, purchasing, communications center, vendors, and hospitals.

PHYSICAL DEMANDS: Requires the ability to exert some physical effort, walking, standing and light lifting, carrying, pushing and pulling materials and objects weighing up to 25 pounds; dexterity in the use of fingers, limbs and body in the operation of equipment. Tasks require extended periods of time at a keyboard. Will require occasional travel.

ENVIRONMENTAL ELEMENTS: Employee works in an office and lab environment with moderate noise levels, controlled temperature conditions, and no direct exposure to hazardous physical substances.
