Moreno Valley Location Fee Schedule:

All fees are collected on a twice monthly basis. A late fee equal to 10% of the amount owed will be assessed on all past due accounts.

Full days are from 6:30 a.m. to 5:30 p.m. (includes breakfast and afternoon snack).
